### Accessibility Plan 2018 - 2021

St Cuthbert's Catholic Primary School Mission Statement:

#### God made us all unique to learn, live and grow. To show care, concern and friendship. To be the best we can, showing Christ's love in all we do.

St Cuthbert's is a very happy and welcoming place, where the needs of all of our children are central to our educational philosophy. We aim to provide an environment where all pupils feel safe and can flourish by responding to individuals in ways which take into account their varied life experiences and particular needs.

As a Catholic school, we aim to develop the social, cultural, intellectual, aesthetic, physical, moral and spiritual attributes of each and every child in our care. St. Cuthbert's is committed to providing an education that enables all pupils to make progress so that they achieve their best, become confident individuals living fulfilling lives and make a successful transition into adulthood. The pursuit of excellence is at the heart of our Catholic school and forms an integral part of the education we offer which enables all pupils to develop their talents to their full potential as a unique person made in God's image.

#### Introduction

The Accessibility Plan should be read in consultation with the SEND Policy, the SEN Information Report and the Annual SEN Report. Together they include details of:

- St. Cuthbert's admission arrangements for pupils with SEN or disabilities
- The steps St. Cuthbert's have taken to prevent pupils with SEN or disabilities from being treated less favourably than other pupils
- The facilities provided to assist access to St. Cuthbert's by pupils with SEN and disabilities. (Children and Families Act 2014, Part 3)

The purpose of this document is to ensure compliance with Schedule 10 of the Equality Act 2010 which requires all schools to produce an Accessibility Plan that identifies the action the school intends to take over a 3 year timescale to prevent disabled pupils from being treated less favourably than other pupils:

- Increase the extent to which disabled pupils can participate in the curriculum
- Improve the physical environment of schools to enable disabled pupils to take better advantage of education, benefits, facilities and services provided and
- Improve the availability of accessible information to disabled pupils.

#### St Cuthbert's Primary School recognises its duty:

- Not to discriminate against disabled pupils in their admissions and exclusions and provision of education and associated services
- Not to treat disabled pupils less favourably
- To take reasonable steps to avoid putting disabled pupils at a substantial disadvantage
- To publish an accessibility plan

#### St Cuthbert's aims to:

- Increase the extent to which disabled pupils can participate in the curriculum
- Improve the physical environment of the school to enable disabled pupils to take better advantage of education, benefits, facilities and services provided
- Improve the availability of accessible information to disabled pupils

## Definition of Disability under the Equality Act 2010 states that a person has a disability if:

#### 'They have a physical or mental impairment that has an adverse, substantial and long term effect on their ability to carry out normal day to day activities.'

St Cuthbert's provides all pupils with a broad and balanced curriculum, differentiated and adjusted to meet the needs of individual pupils and their preferred learning styles. We endorse the key principles which underpin the development of a more inclusive curriculum:

- Setting suitable learning challenges
- Responding to pupils' diverse needs
- Overcoming potential barriers to learning and assessment for individual groups of pupils.

#### The three areas to be considered in the action plan are:

- a) Improving education and related activities. St Cuthbert's will seek and follow the advice of LA services, such as specialist teacher advisers and SEN advisers, and of appropriate health professionals from the NHS Trust.
- **b) Improving the physical environment.** St Cuthbert's will take account of the needs of pupils and visitors with physical difficulties and sensory impairments when planning and undertaking future improvements and refurbishments of the site and premises, such as improved access, lighting, acoustic treatment and colour schemes and more accessible facilities and fittings.
- c) Improving the provision of information. St Cuthbert's Primary School will make itself aware of local services, including those provided through the LEA, for providing information in alternative formats when required or requested.

#### **Contextual Information**

St Cuthbert's Primary School is a highly inclusive school. The large building was formally two separate schools. The EYFS and KS1 are housed in two single storey sections, which are fully accessible to the whole school community. There are two accessible toilets (male and female) on the ground floor. In KS2, Years 3 and 4 are usually housed on the ground floor and Years 5 and 6 are usually housed on the upper storey. There are two accessible toilets (male and female) on the ground floor in Key Stage 2.

The school entrances have ramp access with wide doors for ease of entry.

#### Information about the school's disabled population

The school's population often has children who have some kind of impairment, be it physical or mental. Some children have moderate and specific learning difficulties.

Home visits are undertaken for children beginning Nursery and Reception and if any additional needs have been identified, the LA and health advisers are contacted for support and guidance.

Staff are trained in the use of epipens where necessary and many staff members hold current first aid qualifications. Designated first aiders are made aware to all staff.

Transition meetings are held between class teachers each year. A thorough system of reviews takes place for children on the SEN register and those who have disabilities. Where children have significant health problems, all appropriate adults are informed.

Medical forms are completed by parents and discussed. Where children have significant health problems, all appropriate adults are informed and necessary information is displayed in the kitchen.

#### How appropriate is the current provision?

Staff are highly aware by effective communication of the issues faced by disabled pupils and act to resolve them, e.g. adapting the timetable, lesson content and presentation of resources to ensure better accessibility, planning visits and clubs which are inclusive. Regular CPD addresses the inclusion agenda.

#### **Provision in an Emergency**

Children with specific physical needs have their own personal evacuation plans. Named adults are responsible for their evacuation in an emergency. We have regular evacuation practices for all children.

#### Recent projects to improve the physical environment have included:

#### 2018-2019

- Fenced outdoor learning areas installed in Years 1 and 2
- Sail canopies to ensure Y1 and Y2 access external space during inclement weather
- Forest school outdoor learning area installed next to KS2 yard
- Signage in the buildings and grounds improved in order to ensure that school users find it accessible
- Specialist SEND office set up
- Key Stage 2 wellbeing room installed
- Specialist Science lab created for use by all classes for Science lessons
- Picnic tables set up in shaded area of Key Stage 2 yard
- Adaptation of taps in Reception/Key Stage 1 to improve accessibility

#### 2019-2020

- Outdoor area in Nursery made more accessible in poor weather conditions by laying artificial grass.
- Specialist SEN resource room created for intervention groups. Area equipped with computers and specialist resources for various SEN intervention groups.
- Bespoke area dedicated to teaching and learning for our SEND pupils developed with outdoor learning area and specialist resources.
- Picnic tables set up in Key Stage 1 yard to encourage social interaction.
- Installation of hooks in Key Stage 1 for belongings after wet outdoor play/activities.

• Designated First Aid station in Key Stage 2 for the use of staff to attend to medical needs of all children.
