

# Remote Education Policy for St Cuthbert's Catholic Primary School

# 1. Statement of School Philosophy

St Cuthbert's Catholic Primary School has always strived to be creative, innovative and support our parents/children in the best way possible to make learning purposeful and holistic. Our strategy for remote learning continues this.

## 2. Aims

This Remote Education Policy aims to:

- Ensure consistency in the approach to remote learning for all pupils (Inc. SEND) who
  aren't in school through the use of quality online and offline resources and teaching
  videos
- Provide clear expectations to members of the school community with regards to the delivery of high quality interactive remote learning
- Include continuous delivery of the school curriculum
- Promote good mental health and well-being
- · Consider continued education for staff and parents (e.g. CPD, Supervision)
- Support effective communication between the school and families and support attendance

# 3. Who is this policy applicable to?

- A child (and their siblings if they are also attending St Cuthbert's Catholic Primary School) is absent because they are awaiting test results and the household is required to self-isolate. The rest of their school bubble are attending school and being taught as normal.
- A child's whole bubble is not permitted to attend school because they, or another member of their bubble, have tested positive for Covid-19.
- · All children if a full lockdown happens.

Remote learning will be shared with families when they are absent due to COVID related reasons.

## 4. Content and Tools to Deliver This Remote Education Plan

Resources to deliver this Remote Education Plan include:

- Online tools for EYFS KS1 KS2 (School Website)
- Use of recorded video
- E-mails to parents
- Printed learning resources
- · Physical materials such as stationery
- Use of BBC Bitesize, Oak National Academy, Times Tables Rockstars, Spelling Shed, Reading Eggs (KS1) and Reading Plus (KS2)
- Loan of tablets to pupils who do not have devices at home or where there are multiple children with limited devices

# 5. Home and School Partnership

St Cuthbert's Catholic Primary School is committed to working in close partnership with families and recognises each family is unique and because of this, remote learning will look different for different families in order to suit their individual needs.

St Cuthbert's Catholic Primary School will provide online training for parents on how to navigate our school website and access all online learning.

Where possible, it is beneficial for young people to maintain a regular and familiar routine. St Cuthbert's Catholic Primary School would recommend that each 'school day' maintains structure. Parents have been provided with a suggested timetable for each class.

We would encourage parents to support their children's work, including finding an appropriate place to work and, to the best of their ability, support pupils with work encouraging them to work with good levels of concentration.

Every effort will be made by staff to ensure that work is set promptly. Should accessing work be an issue, parents should contact school promptly and alternative solutions may be available. These will be discussed on case-to-case basis.

All children sign an 'Acceptable Use Policy' at school which includes e-safety rules and this applies when children are working on computers at home.

# 6. Roles and responsibilities

#### **Teachers**

The responsibilities below relate to where a whole class/bubble is isolating and would be reduced when it is fewer children isolating and the majority of the class are in school.

When providing remote learning, teachers must be available between normal school hours.

If they are unable to work for any reason during this time, for example due to sickness or caring for a dependent, they should report this using the normal absence procedure.

When providing remote learning, teachers are responsible for:

- Setting work:
  - o Teachers will set suitable and age appropriate work/activities for the pupils in their classes.
  - The work set will follow the remote learning staff agreement
  - Weekly/daily work will be shared using the school website

Providing feedback on work:

- Pupils can send any completed work to teachers via class email
- Teachers can record / email feedback if required

Teachers should respond to any emails from parents/children within 48 hrs

Keeping in touch with pupils who aren't in school and their parents:

- If there is a concern around the level of engagement of a pupil/s parents should be contacted via email / phone to access whether school intervention can assist engagement.
- Any complaints or concerns shared by parents or pupils should be reported to a member of SLT– for any safeguarding concerns, refer immediately to the DSL

## **Teaching Assistants**

Teaching assistants must be available between their normal working hours.

If they are unable to work for any reason during this time, for example due to sickness or caring for a dependent, they should report this using the normal absence procedure.

During the school day, teaching assistants must complete tasks as directed by a member of the SLT.

#### **Senior Leaders**

Alongside any teaching responsibilities, senior leaders are responsible for:

- Co-ordinating the remote learning approach across the school SLT
- Monitoring the effectiveness of remote learning reviewing work set by teachers
- Monitoring email correspondence between parents and teachers
- Monitoring the security of remote learning systems, including data protection and safeguarding considerations

#### Designated safeguarding lead

The DSL is responsible for managing and dealing with all safeguarding concerns. For further information, please see the Safeguarding and Child Protection Policy.

#### IT Technicians

IT technicians are responsible for:

- Fixing issues with systems used to set and collect work
- Helping staff with any technical issues they're experiencing
- Reviewing the security of remote learning systems and flagging any data protection breaches to the data protection officer
- · Assisting pupils and parents with accessing the internet or devices

#### The SENDCO

□ Ensuring that pupils with EHC plans continue to have their needs met while learning remotely, and liaising with the headteacher and other organisations to make any alternate arrangements for pupils with EHC plans.

#### The SBM

- Ensuring value for money when arranging the procurement of equipment or technology.
- Ensuring that the school has adequate insurance to cover all remote working arrangements.

# **Pupils and parents**

Staff can expect pupils learning remotely to:

- · Complete work to the deadline set by teachers
- · Seek help if they need it, from teachers
- Alert teachers if they're not able to complete work

Staff can expect parents with children learning remotely to:

- Make the school aware if their child is sick or otherwise can't complete work
- · Seek help from the school if they need it
- · Be respectful when making any complaints or concerns known to staff

#### Governors

The governing body is responsible for:

- Monitoring the school's approach to providing remote learning to ensure education remains as high quality as possible
- Ensuring that staff are certain that remote learning systems are appropriately secure, for both data protection and safeguarding reasons

## 7. Who to contact

If staff have any questions or concerns, they should contact the following individuals:

- Issues in setting work talk to the relevant subject lead/SENDCO/SLT
- · Issues with behaviour talk to the SLT
- Issues with IT talk to Assistant Head (C Ferguson) who can contact IT support if needed
- Issues with their own workload or wellbeing talk to the headteacher (A Bullerwell)
- Concerns about data protection talk to the data protection officer (School Business Manager)
- · Concerns about safeguarding talk to the DSL
- · All staff can be contacted via the school email addresses

# 8. Data protection

## Accessing personal data

When accessing personal data, all staff members will:

- All staff have access to CPOMS to record any parent contact or concerns about children, this is accessed via a secure password. Ensure you log out after use. Do not allow access to the site to any third party.
- SLT have the ability to locate personal details of families when required through securely accessing CPOMS. SLT are not to share their access permissions with other members of staff.
- School laptops and iPads are the school's preferred devices to be used when accessing any personal information on pupils.

## Sharing personal data

- Staff members may need to collect and/or share personal data such as emails or phone numbers as part of the remote learning system. Such collection of personal data applies to our functions as a school and doesn't require explicit permissions.
- While this may be necessary, staff are reminded to collect and/or share as little personal data as possible online.

## Keeping devices secure

All staff members will take appropriate steps to ensure their devices remain secure. This includes, but is not limited to:

- Keeping the device password-protected strong passwords are at least 8 characters, with a combination of upper and lower-case letters, numbers and special characters (e.g. asterisk or currency symbol)
- Ensuring the hard drive is encrypted this means if the device is lost or stolen, no one can access the files stored on the hard drive by attaching it to a new device
- Making sure the device locks if left inactive for a period of time
- Not sharing the device among family or friends
- Installing antivirus and anti-spyware software
- Keeping operating systems up to date always install the latest updates
